Subject: registration for Summer Camps 2023 - economic subsidy.

Dear Parents,

The Municipality of Parma is giving an opportunity to the families to participate in the call for application for reductions on the registration fee in the Summer Camps for children aged 3 to 14 years (up to 17 years for children affected by a disability within Law 104/1992) thanks also to the regional funds.

**The Application for the request of the economic subsidy can be submitted from April 17. 2023 at 12 p.m. until May 8. 2023 not later than 11:59 p.m. filling out the ON LINE form on the website of the Municipality of Parma at:**

To proceed with the request for the subsidy you must be in possession of the SPID (Public Digital Identity System) credentials. In the absence of it, you must obtain your SPID credentials by following the steps below:

The families, once they have read the call carefully, will have the chance to submit their request choosing **one and only one** of the following options:

- Application for the allocation of **Buoni comunali** for the attendance of Summer Camps for children **from 6 to 14 years**.

**Or**

- Application for the allocation of **Contributi Regionali** FSE for the attendance of Summer Camps for children **from 3 to 13 years (up to 17 years for children affected by a disability within Law 104/1992)**.

**A single application for assistance may be submitted for each child.**

Once published, the ranking can be consulted on the website of the Municipality of Parma. An individual communication of the assignment will also be sent **through SMS** to the applicant's mobile number indicated in the application.

Subsidies must be used in the chosen Summer Camps **not later than June 9, 2023**. All unused vouchers/contributions **will be annulled** after that date to be subsequently assigned to families on the waiting list.

**In the event of the conclusion of the procedural check made by the Administration after awarding the *buoni comunali* and *contributi regionali* and in the event that the declared requirements are not true, the refund of the voucher/contribution awarded will be requested.**

The concerned families can register their children freely to one or more centres by contacting the secretariats of the Summer Camps.
